The appointees shall report to Chief Horticulture Officer, Ramban within a period of 21 days from the date of issue of this appointment order. In case of failure of appointees to join within the stipulated period, their appointment shall be deemed to have been cancelled without any further notice.

The appointee shall be allowed to join only on the production of following certificates in original:-

- 1/ Date of Birth Certificate/Diploma Matriculation.
- ii/ Qualification Certificates.
- iii/ Age and Health certificate.
- iv/ No loan certificates from the DIC/Employment Department.
- v/ State subject Certificate.
- vi/ Category certificate, if any.
- vii/ Any other document as required under rules.

The appointment of the above candidate as HTG-IV shall further be subject to the following conditions.

- 1) Appointee shall give an undertaking in the shape of an affidavit duly attested by 1st class Judicial Magistrate to the effect that in case any adverse report about his Character and Antecedents is received from Inspector General of Police, (CID) J&K to whom a reference shall be made by the Department, the candidates shall have no right to claim his/her appointment as HTG-IV and their appointment as such shall be deemed to have been cancelled ab-initio. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports is received in their favour.

The appointees shall be on probation for a period of 05 years and satisfactory completion of five years, their services shall be declared as permanent subject to passing of such tests or successfully undergoing such training as provided under the J&K Services (Classification Control and Appeal Rules, 1956) or as prescribed under the recruitment rules governing the post/service to which they have been appointed.

The appointees shall have to necessarily work for a period of five years on the posts against which they have been appointed and such appointees shall not be eligible for transfer on whatsoever reasons during the temporary service of five years.

During the period of first five years, the appointees shall be entitled to minimum scale of pay alongwith grade pay applicable to the posts against which they are appointed and after successful completion of five years period on probation be entitled to fixation of pay in the time scale of pay applicable to the posts against which they are appointed.
