Subject: Acceptance of resignation of Mr. Vivek Chagotra, Lab. Canning Attendant-Termination of probation and discharge thereof.
Reference: Chief Canning and Processing Instructor Jammu's letter No: Craft/J/35 dated 22-04-2019.

Whereas, one Mr. Vivek Chagotra S/o Dharam Paul among others was appointed as Lab. Canning Attendant vide Horticulture Order No. 166/E of 2018 dated 27.09.2018 and was adjusted in the Office of the Chief Canning and Processing Instructor, Jammu with a probation period of five years; **and**

Whereas, subsequently, vide this office order No. Adm/NG/7283-87 dated 19-11-2018 he was deputed to Administrative Department, Horticulture Civil Secretariat, Jammu for further duties and was relieved by Chief Canning and Processing Instructor, Jammu on 29-11-2019 vide No. Craft/J/555-56 dated 29-11-2018; **and**

Whereas, on receiving the reports about his un-authorized absence from the Administrative Department, he was directed to report back to the Office of Chief Canning and Processing Instructor, Jammu vide this office communication No. Adm/NG/ 7889-91 dated 12-12-2018 but he failed to do so. Also his whereabouts were not known; **and**

Whereas, Chief Canning and Processing Instructor, Jammu vide letter No. Craft/J/897-98 dated 7-03-2019 also directed Mr. Vivek Chagotra to resume his duties within a period of 7 days positively and explain his position, as to why, disciplinary action under rules shall not be initiated against him for remaining un-authorizedly absent from the duty; **and**

Whereas, upon this also Mr. Vivek Chagotra, Lab. Canning Attendant did not resume his duties nor explained his position regarding his un-authorized absence; **and**

Whereas, in furtherance to the above a final notice was served upon Mr. Vivek Chagotra, by Chief Canning and Processing Instructor, Jammu vide no. Craft/J/Estt/1050-51 dated 26.03.2019 advising him to resume his duties within a period of 7 days positively failing which, it shall be presumed that he has neither to say anything in defence nor is interested in Govt. job and action as warranted under rules shall be initiated against him, but once again he failed to resume his duties; **and**

Whereas, Mr. Vivek Chagotra on 05.04. 2019 suddenly submitted his resignation from the Government service in the Office of Chief Canning and Processing Instructor, Jammu and requested for acceptance of the same; **and**


Whereas, Chief Canning and Processing Instructor, Jammu forwarded his resignation to this Directorate for acceptance of the resignation; **and**

Whereas, the matter regarding resignation from Government service submitted by the probationer namely Mr. Vivek Chagotra has been considered with reference to the rules governing the subject and it has been found that the request of the probationer can be considered by terminating his probation in Terms of Rule 21 (1), on his own request; and

Now, therefore, in exercise of powers conferred under Rule 21 (1) of Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956, the probation of Mr. Vivek Chagotra S/o Dharam Paul R/o Village Sallan P.O. Dayala Chak, Tehsil Hiranagar, District Kathua, as Lab. Canning Attendant (probationer) is hereby terminated and he is discharged from Govt. Services w.e.f. 29.11.2018 i.e. from the day of his unauthorised absence from the duty.
