Sealed Bids, for and on behalf of the lieutenant Governor of Jammu and Kashmir, Union Territory, are invited from the interested persons for auction of timber wood/lopped wood/pruned wood and stumps at Govt. Fruit Plant Nursery Ludhwal (Chadwal) Kathua for the year 2020-2021.

Bids/offers sealed properly in envelopes should reach in the office of Chief Horticulture Officer, Kathua(Nodal Officer) by or before 20<sup>th</sup> of March 2021 upto 4.30 P.M. These offers will be opened by the Auction Committee on 22<sup>th</sup> March 2021 at 11 A.M. or next working day if 22-03-2021 happens to be a holiday at Chief Horticulture Officer, Kathua presence of the tenderers who wish to be present.

### Terms and Conditions:-


1. The offer should be accompanied with CDR equivalent to 5% of the offered value/bid. The CDR should be drawn on any scheduled bank and pledged to Chief Horticulture Officer, Kathua.
2. The sealed envelopes containing the offer both in figure and words without cutting/overwriting. The cover should also indicate the No. and date of CDR and full address of the bidder.
3. Cheques or cash deposited with the bid/offer as earnest money shall not be accepted or entertained and shall be rejected out rightly and the bidder shall not be allowed to participate in the auction proceedings.
4. The successful Bidder shall have to execute an agreement with the department on non-judicial paper of Rs. 10/- within three days from the date of communicating of approval of the offer to ensure fulfilment of terms and conditions of contract.
5. The successful bidder shall have to deposit/remit full amount of the approved offer/value/cost of timber wood/lopped wood/pruned wood and stumps of particular orchard/nursery on the spot in lump sum with the Chief Horticulture Officer, Kathua against proper receipt.
6. After communicating the approval of bid/offer, if the successful bidder fails to deposit/remit the bid amount and does not execute the agreement in the specifies time limit, it shall be construed as backing out of the contract by the concerned. The

department in that event shall decide the matter on its merits or may re-auction, loss, if any sustained by the Government, on this amount shall have to be made good from the defaulting contractor, and the CDR will be forfeited henceforth.

The successful bidder shall not sub—let the contact. The contractor/Bidder who after communicating approval of offer, if fails to execute the contract, shall be deemed to be "BLACK LISTED" for future auction if any at the department. The tendrer shall have to attach attested copy of identity card with his/her offer. Unsealed tender/offers and overwriting in tender shall not be entertained.
