Sealed bids are invited from the interested persons for auction of fruit crop/green grass/pruned/dry wood of the Departmental Orchards and Nurseries including ACHD Farm Ramban/MFPN Chakroi located in Jammu Division, for the year, 2024 upto December, 2024) in suppression to this office Notice No.:Prod/2024-Auc/47/3436-3463 Dated:12-04-2024.

Bids/offers sealed properly in envelopes should reach in the office of **Chief Horticulture Officer, Jammu (Nodal Officer) or Chief Horticulture Officer concerned District** by or before **11<sup>th</sup> of May, 2024 upto 4.30 P.M.** These offers will be opened by the Auction Committee **on 15<sup>th</sup> of May, 2024 at 11 A.M** or next working day if **15<sup>th</sup> of May, 2024** happens to be a holiday at Horticulture Complex, Talab Tillo Jammu in presence of the bidders who wish to be present.

Terms and Conditions:

- i The offer should be accompanied with security deposit in the form of CDR/FDR equivalent to 5% of the offered value/bid. The CDR should be drawn on any scheduled Bank and pledged to **Chief Horticulture Officer, Jammu/Chief Horticulture Officer** concerned District.
- ii Separate offers should be quoted/deposited for fruit crop of each Orchard/ Nursery/ Farm and also Dry wood.
- iii. The sealed envelopes containing the bids both in figure and words should also indicate the name and other particulars of the Orchard/Nursery/ Farm and District for which offer has been made. **The cover should also indicate the No. and date of CDR and full address of the tenderer.**
- iv. Cheques or cash deposited with the bids/ offer as earnest money shall not be accepted or entertained and shall be rejected out-rightly and the bidders shall not be allowed to participate in the auction proceedings.
- v. The successful bidders shall have to execute an agreement with the Department on non-judicial paper of Rs. 10/- within three days from the date of communication of approval of the offer to ensure fulfillment of terms and conditions of contract.
- vi. The successful bidders shall have to deposit/remit full amount of the approved offer/ value/ cost of fruit crop/green grass/dry wood of particular Orchard/ Nursery/ Farm on




the spot in lump sum with the respective Chief Horticulture Officer, against proper receipt.

- vii. After communicating the approval of bid/offer, if the successful bidder fails to deposit/remit the bid amount and does not execute the agreement in the specified time limit, it shall be construed as backing out of the contract by the concerned. The Department in that event shall decide the matter on its merits or may re-auction the fruit crop of the respective orchard. Loss, if any sustained by the Government, on this account shall have to be made good from the defaulting contractor, and the CDR will be forfeited henceforth.

The successful bidder shall not sub-let the fruit crop/green grass/ dry wood. In such case the bid will be cancelled and auction amount as well as the CDR shall be forfeited. Contractor, who after communicating approval of offer, if fails to execute the contract, shall be deemed to be "**BLACK LISTED**" for future auction by the Department. The bidders shall have to attach attested copy of identity card with his/her offer. Unsealed bids/offers and overwriting in bid shall not be entertained.
