As per selection made by J&K Service Selection Board vide their letter No: SSB/Secy/Sel/209/18/J/788-90 dated: 24-01-2019 and copy whereof received in this office under the cover of Administrative Department letter No. referred to above, Sh. Suresh Kumar S/o Sh. Om Parkash, R/o Dassal-Rajouri is temporarily appointed as Driver in the pay scale of Level-2 (19900-63200) in Horticulture Department (District Cadre-Rajouri).

The appointee shall report to Chief Horticulture Officer, Rajouri within a period of 21 days from the date of issuance of this appointment order. In case of failure on part of the appointee to join within the stipulated period, his appointment shall be deemed to have been cancelled without any further notice. **The appointee shall be allowed to join only on the production of following certificates:-**

- i. Date of Birth Certificate/Diploma Matriculation.
- ii. Qualification Certificates.
- iii. Age and Health Certificate.
- iv. No loan certificates from the DIC/Employment Department.
- v. State Subject Certificate.
- vi. Driving Licence.
- vii. Category Certificate, if any.
- viii. Any other document as required under rules.

The appointment of the above candidate as Driver shall further be subject to the following conditions:-

1. The Salary of the appointee shall be disbursed to him only on receipt of the verification report with regard to character and antecedents from the verifying

agency viz. CID. In case, the candidate is adversely reported upon by the verifying agency or the category or any other certificate is not found genuine/valid, he shall have no claim to hold the post to which appointed. His appointment shall stand automatically deemed to be cancelled without any further notice.

2. The appointee shall be on probation for a period of 05 years and after satisfactory completion of five years, his services shall be declared as permanent as provided under the J&K Civil Services (Classification Control and Appeal Rules, 1956) or as prescribed under the relevant recruitment rules governing the post/service to which they have been appointed.
3. The appointee shall have to necessarily work for a period of five years on the post against which he has been appointed and such appointee shall not be eligible for transfer on whatsoever reasons during the temporary service of five years.
4. During the period of first five years, the appointee shall be entitled to minimum of pay scale against which he is appointed and after successful completion of five years period on probation, be entitled to fixation of pay in the time scale of pay applicable to the posts against which he has been appointed.
