The release of funds is subject to the following conditions:-

1. The Chief Horticulture Officers shall indicate in their sanction, Component-wise break up of funds to be Utilized. A copy of the sanction order shall be sent to this Directorate for information and record. The Chief Horticulture Officers are also advised to adhere training programme issued by this Directorate vide letter No:- Horti/Dev/Tech/5548-57 Dated:- 19-09-2018 and the photography (Still/Video) be furnished to HIPO Jammu under an intimation to this office.

- 2. The funds shall be utilized strictly on the approved components as per the approved State Extension Work Plan 2018-19 under CSS Submission of Agriculture Extension (SMAE) strictly on the approved components and as per the guidelines of the scheme.
- 3. The Chief Horticulture Officer shall ensure that accounts are maintained and are subject to normal process of statutory audit likewise, an inventory of the assets created under the projects should be carefully preserved and assets that are no longer required shall be transferred to the Nodal department for its use and re-deployment wherever possible;
- 4. The Chief Horticulture officer shall ensure that funds released are utilized prudently and judiciously and in no case they should book the expenditure just for the sake of spending;
- 5. The expenditure shall be incurred only after observing al codal formalities required under rules;
- 6. The Chief Horticulture Officer shall restrict the expenditure to the actual availability of funds and no liability shall be created in any case;
- 7. The Chief Horticulture Officer shall ensure that there is no overlapping/duplication in adoption of schemes/incurring of expenditure from any other scheme of the State or Central Government;
- 8. The DDOs shall furnish progress (both in physical and financial) to this Directorate by or before 3rd of every consecutive month for its compilation and onward submission to the Administrative Department;
- 9. The release of funds should not be taken as final authority for utilization and the Chief Horticulture Officer should satisfy himself about the techno-economic viability of the scheme/components to ensure optimum utilization of funds;
- 10. The Chief Horticulture Officer shall submit Utilization Certificate by or before 31-12-2018 along with physical and financial progress Reports.
- 11. Wherever Direct Benefit Transfer (DBT) is involved, applicable guidelines including Adhaar Linkage shall be complied strictly;
- 12. The Chief Horticulture Officer shall implement the programme/work after accord of administrative approval/technical sanction, wherever required by the competent authority
- **13.** The Chief Horticulture Officer shall vouchsafe the utilization of the funds as per the codal procedures/GOI guidelines.
- 14. All Kisan Melas/similar activities in the districts will be conducted after the due approval of the concerned District Development Commissioner and also ensure the participation of the District Agriculture Officer and other allied District Officers.
- **15.** Treasury Officers shall not allow parking or drawl of funds in the civil deposit without prior concurrence of the Finance Department.
- **16.** Funds authorized under State Share shall be equitably utilized in the ratio 90:10 for implementation of the programme in proportion to the release of Central Share and no excess amount of State Share be expended in violation of guidelines/norms of the scheme.
- 17. Funds released under Central Share be utilized in consonance with the detailed heads and amount mentioned in Annexure enclosed with this order.

18. The funds shall be debited to the Appropriate Head of Account as per BEAMS.
