Sanction is hereby accorded to the release for an amount of Rs. 2.70 lacs (Rupees Two lacs Seventy Thousand only) as Central Share and placed at the disposal of Chief Horticulture Officer, Jammu for implementation of Action Plan 2017-18 under Centrally Sponsored Scheme, "Mission for Integrated Development of Horticulture(MIDH) " to be utilized during 2017-18.

The expenditure shall be debited to following Head of Accounts:-

The release of funds is subject to the following conditions:-

1. The implementing agency shall utilize the funds as per approved Action Plan 2017-18 for "Mission for Integrated Development of Horticulture (MIDH)" after observing codal formalities and in consonance with the guidelines of the scheme.
2. The authorization shall not be applicable to the centrally sponsored schemes for which funds are to be utilized only after there are released by the concerned Union Ministry.
3. For training/awareness camps/demonstration/publicity, the department shall utilize the normal Centrally Sponsored Scheme implemented by the departments for MIDH Action Plan during 2017-18.
4. The Drawing and Disbursing Officer shall ensure that funds released are utilized prudently and judiciously and in no case they should book the expenditure just for sake of spending.
5. The Drawing and Disbursing Officer shall implement the programme/activity/component on the cost normal guidelines/subsidy component at par which are admissible/ permissible in the normal centrally sponsored scheme implemented by the department for MIDH Action Plan during 2017-18.
6. The expenditure shall be incurred only after observing all codal formalities.
7. The Drawing and Disbursing Officers shall restrict the expenditure to the actual availability of funds and no liability shall be created in any case.
8. The Drawing and Disbursing Officer shall ensure that there is no overlapping/duplication in adoption of schemes/ incurring of expenditure from any other schemes of the State or Central Government.
9. No re-appropriation/diversion of funds is allowed in any case.
10. The Drawing and Disbursing Officer shall furnish progress (both physical and financial) regularly to this office for its submission to Government of India/Administrative Department.
11. The Drawing and Disbursing Officer shall furnish utilization certificate on monthly basis alongwith physical and financial progress.
