Subject: Final senority list of Senior Assistants of Horticulture Department, Jammu Division as it stood on 01/04/2020.

Whereas, a final seniority list of ministerial staff of Department of Horticulture, Jammu Division was issued vide Horticulture order No. 271/E of 2013 dated 17/05/2013;

Whereas, Mr. Rakesh Singh, Sr. Assistant filed a Service Writ Petition No. 1456/2013 in the Hon'ble High Court of J&K at Jammu;

Whereas, the Hon'ble High Court vide its judgment dated 09/07/2013 stayed the operation of seniority list, the operative part of which is as under:-

> "In the meantime till next before the Bench, order No.271/E of 2013 dated 17.05.2013 passed by Director, Horticulture Department Jammu shall not be given effect to."

Whereas, on 7th March, 2020 all the Senior Assistants were called in the office chamber of Director Horticulture, Jammu wherein they have submitted their representations indicating therein that they have no objection, if seniority list of Sr. Assistants is finalized afresh;

Whereas, keeping in view the representations of all the Sr. Assistants falling in District/ Divisional cadre, a tentative seniority list of Sr. Assistants of Horticulture Department, Jammu Division was framed purely on the basis of service particulars received from sub-ordinate offices of the Department viz-aviz claim of the officials mentioned in their representation and circulated for general information and inviting objections, if any, within 15 days vide this office circular No. 54/DHJ of 2020 dated 07/03/2020 issued under endorsement No.Horti/Adm/NG/1959-74 dated 07/03/2020.

Whereas during the said period no representation/ objection has been received from any of the official and it is presumed that all the concerned officials whose name stood in the said tentative list are satisfied and have no objection to the finalization of the said tentative list.

Now therefore, the final seniority list of Sr. Assistants of Horticulture Department, Jammu Division falling in Divisional/ District cadre as per Annexure-"A" to this communication is hereby issued accordingly for information of all the concerned.

The seniority list shall be without prejudice to the final outcome of any writ petition, if any, pending in the competent court of law.
